THOMAS PILGERMAYER Professional Assistance Program Information

The Southeastern Pennsylvania Chapter (SEPA) of The Society of Human Resource Management is honored to establish scholarship awards in the memory of Thomas Pilgermayer, a founding Chapter Board Member and a former Human Resources Director at Jeanes Hospital. Tom Pilgermayer continually emulated the high standards of Human Resource Management and remained a gifted professional for many years. Two \$1,000 scholarships will be available to be awarded each year for a total of \$2,000 annually. The awards will be granted to applicants based on one of the following two programs:

1. To cover the direct cost of the HR professional certification courses and/or the direct cost of the exam.
 - i. The candidate is enrolled (or has made application to enroll) in a Villanova SHRM University-based cert-prep course to prepare the applicant for the PHR or SPHR certification and/or;
 - ii. The candidate meets the Human Resource Certification Unit (HRCI) eligibility requirements to sit for the certification exam at the level of PHR or SHPR; and is planning to sit for an upcoming exam.
2. For full or part-time enrollment in an accredited undergraduate or graduate college program and has a desire and commitment to pursue Human Resource Management as a career. The financial assistance is for qualified expenses, i.e., tuition and fees paid to enroll in or attend and educational institution and fees, books, supplies and equipment that are required for the courses.

The candidate must be a current professional, general, student or life member in good standing of SHRM National and the SEPA chapter or the affiliated Temple Ambler student SHRM chapter at the time the scholarship application is submitted. The candidate is ineligible for this award if they are receiving reimbursement from another party for the same fees/expenses.

Candidates are to complete an application that includes a written letter to the Board of the SEPA chapter stating why he/she is interested in certification or HR learning and how he/she expects to benefit from the process. Candidates must be specific regarding the intended use of the funds, date of the exam sitting, and will be required to submit proof of enrollment and cost for the certification course and/or test.

Letters and applications will be evaluated by the SEPA SHRM Chapter Board of Directors. Submitted letters should be typed and no more than 2 pages long. All applications are to be submitted to (the Vice President of Education). Submitted papers become the property of SEPA SHRM and will not be returned.
