March 18, 2008

In April, the Pennsylvania State Council of SHRM will host its' annual legislative conference. At this meeting, new and pending State Legislation will be discussed.

In addition, the legislative process in Pennsylvania will be reviewed and ways to impact the process will be presented.

At our March 2008 meeting, Jonathan Segal will present a synopsis of proposed 2007 and 2008 legislation that will affect the HR Profession as well as our respective workplaces. Various areas of legislation will be presented, including proposed amendments to the Pennsylvania Human Relations Act, the "Healthy Families, Healthy Workplaces" Act, and the Employee Rehabilitation and Drug Standards Act.

Our March meeting will serve as a primer for those attending the April legislative conference, and an update of pending legislation for those that are not able to attend.
