In his position as a Program Analyst, Kurt Jung is the Philadelphia District Office's primary speaker to employer and constituent groups. He serves as the district's small business liaison, and is experienced in the investigations of employment discrimination charges.

Prior to working for the EEOC, Mr. Jung worked for the Department of the Navy and the Department of Justice where he was involved with the counseling, investigation, and litigation of employment discrimination cases in the federal sector. In 2002, he was appointed by the Governor of New Jersey to serve as a Commissioner on the New Jersey Asian American Commission.

Mr. Jung currently serves on the Superior Court of New Jersey's Burlington Vicinity Advisory Committee on Minority Concerns. He is a licensed attorney for the State of New Jersey and a graduate of Temple University School of Law.
